I am writing in my capacity as a jury member of the ERF-Nagad Best Reporting Award 2023, a nationally recognized annual journalism award presented by the Economic Reporters' Forum (ERF), in partnership with Nagad Ltd., a leading mobile financial service provider in Bangladesh. This award recognizes outstanding contributions to economic journalism in Bangladesh.

As the Founder of Digitally Right, Associate Professor at Bangladesh University of Professionals (BUP), and former Editor of GIJN Bangla, I have been deeply involved in advancing investigative journalism, media literacy, and digital rights in South Asia. I also personally know Mr. Md Kamruzzaman, known professionally as Babu Kamruzzaman, and am familiar with his impactful work in the field of economic journalism.

In 2023, I served on a **six-member** independent jury panel that included:

- Dr. Wahiduddin Mahmud, Adviser to the Former Caretaker Government of Bangladesh and Former Professor, University of Dhaka
- A. A. M. S. Arefin Siddique, Former Vice Chancellor, University of Dhaka
- Barrister Nihad Kabir, Former President, Metropolitan Chamber of Commerce and Industry
- Dr. Khondaker Golam Moazzem, Research Director, Centre for Policy Dialogue (CPD)
- Shamsul Hug Zahid, Editor, The Financial Express

The jury evaluated 168 submissions from leading journalists across television, print, and digital media. The process involved a two-tiered evaluation: a preliminary screening conducted by ERF's technical committee, followed by jury assessment using standardized criteria including:

- Originality and depth of reporting
- Public relevance and impact
- Clarity of presentation
- Adherence to ethical journalism practices

From this rigorous and highly competitive process, 19 journalists were selected for awards. Mr. Kamruzzaman was selected as the winner in the "Private Sector" category, in recognition of his exceptional analytical reporting that significantly contributed to public understanding of private sector issues in Bangladesh.

The award ceremony took place on November 6, 2024, at Pan Pacific Sonargaon Hotel, Dhaka, in the presence of senior policymakers, business leaders, and media professionals. Awards were presented by:

- Dr. Salehuddin Ahmed, Finance Adviser, Government of Bangladesh
- Dr. Ahsan H Mansur, Governor, Bangladesh Bank
- **Dr. KAS Murshid**, Chairman, Nagad Ltd.



Mr. Kamruzzaman received a commemorative crest and a monetary award of BDT 1,00,000, presented on stage before a distinguished audience.

The ERF, founded in 1993–94 and registered under the Companies Act 1913, is the most prominent association of economic journalists in Bangladesh, with over 250 members representing major national media.

I affirm that Mr. Kamruzzaman's selection was based on merit and reflects his national-level recognition in economic journalism. His work stood out among a large and competitive pool of applicants, further affirming his contributions to the field.
